**Site Plan Requirements**

- Limits of plan should depict all property boundaries
- All existing conditions on the site should be depicted
- Any proposed changes to existing landscaping should be depicted
- Location and number of charging stations
- Location of all above & below ground utilities and infrastructure
- Note whether spaces are reserved specifically for EV charging
- Lighting plan ([see standards described here](#))
- Bollard details for vehicle protection
- Screening of installation may be required if adjacent to a residential land use
- Parking spaces shown and dimensioned ([see standards described here](#))
- Vehicle movement plan (if the location is such that traffic flow may be impacted)
- Elevations / manufacturer specifications
- Signage location and details (note that signs are approved by separate permit)
- One line diagram
- Note: EV charging stations may not be located within any City-identified riparian setback area. Additional review may be necessary if the EV station is proposed in a wetland or floodplain.
